

THE FREEDOM TO TRAVEL CAMPAIGN IS dedicated to changing U.S. policy toward Cuba by lifting the prohibition on legal travel by Americans to the island.

We believe that the travel ban is wrong. It denies Americans their constitutional right to travel. It denies profits to U.S. air carriers and others in the travel industry and keeps them from creating jobs. Most important, it prevents the American people and the Cuban people from meeting and learning from each other.

At its core, Freedom to Travel is a public education campaign on the need to lift the travel ban. We have brought scores of U.S. Members of Congress to Cuba; we have enabled farmers, entrepreneurs, and performing artists to learn from their Cuban counterparts. Finally, we have worked in coalition with business and industry groups, policy activists and other organizations of conscience to campaign for a new Cuba policy and an end to the travel ban.

We are at the leading edge of progress. In 2003, a strong majority of Democrats and Republicans voted to advance the cause of freedom in Cuba and the constitutional rights of Americans to travel where they wish. But more needs to be done.

In the weeks and months ahead, we will intensify our campaign to help the Cuba Working Groups in the House and the Senate educate and motivate their colleagues to change U.S. policy toward Cuba.

Together we will expand support for a policy that is in the economic and national security interests of the United States and which will benefit the Cuban people: Repeal of the ban on travel to encourage more contact and commerce between the people of the United States and Cuba.

CIP'S FREEDOM TO TRAVEL CAMPAIGN

has led numerous trips to Cuba with Members of Congress and other policy and business leaders. In 2003 it co-sponsored a delegation from the bipartisan House Cuba Working Group, another led by Senator Kent Conrad (D-ND), and also one led by Senator Max Baucus (D-MT). On all of our trips, Members of Congress have stressed the importance of political reform while expanding diplomatic and economic relations with Cuba.

The Freedom to Travel Campaign also hosted a trip to Cuba after the crackdown to meet with the leaders of the political dissident movement there. We had lengthy meetings in the homes of several dissident leaders, including Oswaldo Paya and Elizardo Sanchez. We then reported back in the U.S. on what we heard directly from the dissidents to ensure that their voices were heard during travel policy debate in Washington.

Along with three allied organizations, we hosted a "Freedom to Travel Forum and Day of Action" on Capitol Hill in July 2003. Cuban-Americans from around the United States attended the conference and then lobbied their congressional representatives. The conference included senior Senators and Representatives from both political parties, and policy experts in fields ranging from economics to human rights.

IN JANUARY, 2003, THE FREEDOM TO

Travel Campaign hosted a strategy session in California that brought together Cuba policy experts, Members of Congress, activists, political consultants, moderate leaders in the Cuban-American community and core supporters. We developed a 50-page strategy plan for building support to lift the embargo and we are continuing to implement the essential elements of that plan with new and significant levels of cooperation.

The Freedom to Travel Campaign launched and operates www.cubacentral.com, a website dedicated to Cuba travel. The site is co-sponsored by 20 organizations, and has built a list of over 10,000 Cuba activists from around the country. These activists receive regular email alerts and are repeatedly mobilized to make their voices heard to congressional representatives, the president, and other government leaders. 





